FEE DESCRIPTIONS

TUITION	Tuition covers rent, utilities, other forms of overhead, payroll, and liability insurance for all teams, and mandatory summer skills camp for Elite and Worlds Teams. Total expenses for the season are divided into equal monthly installments that are non-refundable for any reason after the due date. The discounts available are: early registration (5% by June 1), employees (25%), SNAP (10%), and military (10%). This fee also includes up to 6 hours of free UMDGC open workouts for ages 7+. To withdraw from UMAS Team, a UMDGC Request Form MUST be completed and confirmed before the due date.
COMPETITION FEE	Covers all of the expenses related to competing: coaches credentials & background checks, program USASF membership fee, bows/scrunchies, materials related to all star competitions, choreography, music, Spirit Gift Fee, registration fee and coaches travel fees for all regular season competitions, and other competition-related expenses. Competition Fees are non-refundable for any reason after the listed deadline. Tentative schedule will be released in late summer and "final" schedule in -mid-fall. If a competition is canceled, the fee will be deducted from the amount owed for postseason competitions.
UCA COMPETITION FEE	THE LISTED PRICE IS THE FEE FROM UCA 2025. The UMAS Youth, Junior, and Senior Elite & Worlds teams will be attending UCA All Star Championship at the Walt Disney World Resort in March 2026; Mini Elite teams are TBD. Pricing will be released by UCA in October and an informational meeting will be held afterwards. Once notified by UMAS, it is the parent's responsibility to make payment directly to Varsity for their cheerleader's commuter pass by UCA's deadline. The coaches' travel costs are included in the competition fees. Please note that UMAS will not be staying in the resorts as a team; the commuter fee will allow athletes to stay with their family in any local hotel.
POSTSEASON COMPETITIONS	LISTED PRICES ARE FEES FROM 2024-25 SEASON. DATES AND PRICES ARE APPROXIMATE AND WILL DEPEND ON WHEN AND TYPE OF BID RECEIVED. Summit and Worlds qualifying cheerleaders will pay for a commuter pass to Varsity/USASF by the deadlines listed by the competition hosts; UMAS will handle the payments for Regional Summit. In addition, a fee may be due to UMAS to cover expenses related to these competitions: sendoff, extra practices, practice attire, and processing fees for the registration/rostering process. However, the UMAS Booster Club has been able to fundraise to cover these latter fees in the past and they are hoping to do so again in the upcoming season. This fee is not included in the Automatic Payments.
UNIFORMS	Each cheerleader must purchase a uniform for each team they are a full or crossover member prior to the ordering deadline. Cheerleaders do not need to purchase items they already have that still fits correctly. Used uniforms may be available to purchased in the second or third seasons of use.
USASF REGISTRATION	Annual membership with U.S. All Star Federation. It is the responsibility of the parent/guardian/adult athlete to process the membership by the listed deadline. Fee is valid August 1 to July 31. Listed fee is the price from USASF for 2024-25.
MISCELLANEOUS EXPENSES	The PLs will occasionally ask for donations or contributions for coaches gifts, team bondings, parties for postseason bids, etc. These items are completely optional.
